

Shelby County State Bank “Piggy Bank Roundup” Sweepstakes (“Sweepstakes”)  
Official Rules

**NO PURCHASE, APPLICATION, OR USE OF SPONSOR PRODUCTS OR SERVICES NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States who are parents or guardians of children who are 0 to 12 years of age at the time of entry. Employees of Shelby County State Bank (“Sponsor”), and each of their immediate family members (spouse, and parents, children and siblings, and their respective spouses regardless where they live) and individuals living in the same households of the above, whether or not related, are not eligible to enter or win a prize. Each entrant by participating in the Sweepstakes agrees to be bound by these Official Rules and Sponsor’s decisions. The Sweepstakes is subject to all applicable federal, state, and local laws, rules and regulations. Void where prohibited or restricted by law, rule or regulation.

**2. SWEEPSTAKES PERIOD:** Sweepstakes begins at 12:00 a.m. Central Time (“CT”) on February 1, 2018 and will end at 11:59 p.m. CT on February 28, 2018.

**3. HOW TO ENTER:** To be eligible to enter, parents or guardians must take a picture of your child with a piggy bank and submit it to Sponsor using any one of the following methods for entry:

- 4) Mail your “Piggy Bank Roundup” photo entry to SCSB, PO Box 29, Harlan, IA 51537

All photo entries may then be posted on SCSB’s Twitter and Facebook pages.

To enter without taking a photo, hand print your name, address, day and evening phone numbers, email address and date of birth on a 3” x 5” piece of paper and mail it in an envelope with proper postage to “Piggy Bank Roundup”, c/o SCSB, PO Box 29, Harlan, IA 51537. You will receive one (1) entry for the drawing period. Limit: One (1) entry per envelope. All mail-in entries must be handwritten and must be postmarked by and received by, the dates listed above in Section 4. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: You may provide up to one (1) entry into the “Piggy Bank Roundup” promotion, regardless of entry method. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address.

Limit of one (1) entry per child during the Sweepstakes Period. Multiple entries per child are prohibited and will void all entries for that child during the Sweepstakes Period.

The name of the parent or guardian registered via Twitter, Facebook, or email account must be the authorized account holder of the associated email address or social media page, otherwise, the entry may be deemed void. In the event of a discrepancy in the identity of the potential winner, the entry will be declared made by the authorized account holder of the email address or social media account at the time of entry, and the potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of said email address or social media account.

No photocopied, computer generated facsimiles, mechanically reproduced, or mass entries permitted.

**4. DRAWING:** One (1) random drawing will be made for the “Piggy Bank Roundup” promotion. The Sweepstakes begins on February 1, 2018 at 12:00 a.m. Central Time ("CT"), ends on February 28, 2018 at 11:59 p.m. CT (the "Promotion Period") as outlined in the chart below.

Sponsor’s computer is the official time-keeping device for the Sweepstakes.

Entries not selected in a particular drawing will be included in subsequent drawings for this Sweepstakes. All drawings will be done under the direction of Sponsor, whose decisions are final in all matters relating to the Sweepstakes.

**5. ODDS:** The odds of winning depend upon the total number of eligible entries received.

**6. PRIZES:** A total of three (3) prizes \$50 cash prizes will be awarded. Winner is responsible for the payment of all federal, state, and local taxes on the prize. No substitution, or transfer of prizes permitted except at the sole discretion of Sponsor, who reserves the right to substitute a prize (or portion thereof) with one of comparable or greater value, at its sole discretion.

**7. WINNER NOTIFICATION:** Each potential winner will be notified via phone or email approximately one (1) hour after being selected. If the winner does not reply to Sponsor within twenty-four (24) hours after receipt of notification of his/her name being drawn as the potential winner, or in the event of noncompliance with these Official Rules, the prize will be forfeited and may be awarded to an alternate winner. If a winner cannot be confirmed and verified within ninety-six (96) hours from the initial drawing for the respective home game, the prize will not be awarded. By entering the Sweepstakes, entrants agree to the use by Sponsor and its designees of their name, Child's name and age, city and state, and photograph/likeness of entrant, Child, and/or guests for advertising, promotional and other purposes, worldwide and in perpetuity, in any and all forms of media, now known or hereafter devised (including and without limitation, the Internet) without additional compensation, except where prohibited by law.

**8. LIMITATION OF LIABILITY:** By participating in the Sweepstakes, entrants, or, if minors, their parents or legal guardians, agree to release, indemnify and hold harmless Releasees from and against any injuries, losses, damages, claims, actions and any liability of any kind resulting from or arising from participation in the Sweepstakes or acceptance, possession, use, misuse or non-use of the prizes that may be awarded. This Sweepstakes and these Official Rules shall be interpreted in accordance with the laws of the State of Iowa without regard to its principles of conflicts of law and jurisdiction and venue shall be solely within the State of Iowa. If in Sponsor's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if computer viruses, bugs, unauthorized intervention, fraud, or technical difficulties or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Sweepstakes, Sponsor at its sole discretion reserves the right to disqualify any individual who tampers with the entry process and/or void any entries submitted fraudulently, to modify or suspend the Sweepstakes, or to terminate the Sweepstakes and conduct a random drawing to award the prize using all eligible non-suspect entries received as of the termination date. Winners are limited to one (1) prize from Sponsor within any three hundred sixty-five day period. As a condition of entering the Sweepstakes, entrants, or if a minor, their parents or legal guardians agrees that: a) under no circumstances will entrants be permitted to obtain awards for, and entrants hereby waive all rights to claim, punitive, incidental, consequential, or any other

damages, other than for actual out-of-pocket expenses; b) all causes of action arising out of or connected with this Sweepstakes or the prize awarded, shall be resolved individually, without resort to any form of class action; and c) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred and in no event shall entrant be entitled to receive attorneys' fees or other legal costs. Sponsor reserves the right to modify prize award procedures.
