

Cyclone Fan Card – Game Time! (“Sweepstakes”)
Official Rules

NO PURCHASE, APPLICATION, OR USE OF SPONSOR PRODUCTS OR SERVICES NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY:

To be eligible for the sweepstakes, entrants must use their Shelby County State Bank Cyclone Fan Card during the month of March 2018. Each entrant, by participating in the Sweepstakes, agrees to be bound by these Official Rules and Sponsor’s decisions. The Sweepstakes is subject to all applicable federal, state, and local laws, rules and regulations. Void where prohibited or restricted by law, rule or regulation. Eligibility: To be eligible for the contest, you must be a lawful permanent resident of the United States, 18 years of age or older and must not be considered a minor in your state of residence at the time of entry. Contest void where prohibited by law. Employees of Shelby County State Bank, officials and members of their immediate families are not eligible to participate in the contest. Any winning customer entry will be deemed to have been made by the individual named on the Shelby County State Bank account on file.

2. SWEEPSTAKES PERIOD: Sweepstakes begins at 12:00 a.m. Central Time (“CT”) on March 1, 2018 and will end at 11:59 p.m. CT on March 31, 2018. If you do not wish to receive automatic entry by making a purchase with a Shelby County State Bank Cyclone debit card between March 1 and March 31, 2018, you must email webmst@scsbnet.com or mail us at Cyclone Fan Card Contest, Shelby County State Bank, 508 Court St., Harlan, IA 51537 and instruct us not to enter you. If you do not have a Cyclone Fan Card, or are not a customer of SCSB and desire to enter the Cyclone Fan Card Contest, print your name, address, telephone number on a “4×6” card and mail the card to Cyclone Fan Card Contest, 508 Court St., Harlan, IA 51537. Entries are unlimited; however, each mail-in entry must be mailed in a separate postmarked, stamped envelope. Entrants may enter only by using one of the entry methods described in these rules. Mailed entries must be postmarked and received prior to April 3, 2018. Entries will not be acknowledged or returned. Illegible entry materials will be disqualified. Entrants are responsible for all third-party imposed costs and fees, including the cost of postage. Proof of mailing does not constitute proof of delivery. Participants agree not to hold Shelby County State Bank, their partners, their employees and/or their affiliates responsible for lost, late, incomplete, misdirected, damaged, postage due or illegible entry materials.

3. HOW TO ENTER: To enter the Sweepstakes, individuals will have an automatic entry for every signature and PIN purchase during the promotional period, including Automated Teller Machine (ATM) transactions, using a Shelby County State Bank Cyclone Fan Card. There is no limit to the number of entries that an individual may have. No purchase or payment of any kind is necessary to enter or win. Shelby County State Bank employees and immediate family are not eligible.

4. DRAWING: Three (3) random drawings will be made on April 3, 2018.

5. ODDS: The odds of winning depend upon the total number of eligible entries received.

6. **PRIZES:** One (3) Prizes of \$100 will be awarded. Winner is responsible for the payment of all federal, state, and local taxes on the prize. No substitution, cash equivalent, or transfer of prizes permitted except at the sole discretion of Sponsor, who reserves the right to substitute a prize (or portion thereof) with one of comparable or greater value, at its sole discretion. Shelby County State Bank will randomly select three (3) Prize Winners from all entries received throughout the contest period. Prize drawings will occur on April 3, 2018. Shelby County State Bank reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the contest and/or the redemption of the Grand Prizes. All decisions are final and binding. Neither Shelby County State Bank, not its employees, partners, and affiliates, are responsible for and shall not be liable for late, lost misdirected or unsuccessful efforts to notify winner.

7. **WINNER NOTIFICATION:** The winner will be notified approximately one (1) hour after being selected. If the prize notification is undeliverable, the winner does not reply to Sponsor within forty-eight (48) hours after receipt of notification of his/her name being drawn as the potential winner, or in the event of noncompliance with these Official Rules, the prize will be forfeited and awarded to an alternate winner. If a winner cannot be confirmed and verified forty-eight (48) hours after announcing the alternate winner, the prize will not be awarded.
