SCSB's Pays for A's Scholarship Drawing Official Rules

SCSB's "Pays for A's" Sweepstakes Official Rules NO PURCHASE OR ACCOUNT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **Eligibility:** There is no charge, fee, purchase, or other consideration required to enter SCSB's "Pays for A's" sweepstakes (the "Sweepstakes"). Qualified entrants are limited to middle school, junior high and high school students enrolled in public or private Iowa schools in and adjacent to AHSTW, Exira-EHK, Harlan Community, IKM-Manning, MVAOCOU, and OABCIG who receive "A" letter grades on their report cards.

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Sponsor & Administrator: SCSB, PO Box 29, Harlan, IA 51537
- 3. **Timing:** The Sweepstakes run continually and consists of two (2) entry periods per year, each "Entry Period" as outlined below.

Entry Period One Start at 12:00 a.m. CT, July 1 End at 11:59 p.m. CT, January 31 Drawing on or before February 15

Entry Period Two Start at 12:00 a.m. CT, February 1 End at 11:59 p.m. CT, June 30 Drawing on or before July 15

Sponsor's computer is the official time-keeping device for the Sweepstakes.

- 4. How to Enter: To enter the Sweepstakes, an entrant must be present any SCSB with his or her most recent report card with at least one "A" grade along with the student's name, grade, school name, and location to be considered for the Sweepstakes. Entries may also be accepted by mail to SCSB, PO Box 29, Harlan, IA 51537, by fax, 712.755.2869 or emailed to webmst@scsbnet.com. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.
- 5. Limit: Each entrant may enter the "A's" on his or her report card each semester, for a total of two (2) entries per Entry Period. Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different identities, or any other methods will void that entrant's entries and that entrant may be disqualified.
- 6. **Drawings**: An Administrator will randomly select the potential Sweepstakes winners from all eligible entries received during the applicable Monthly Entry Period on or around

the dates listed above in Section 3. After two Entry Periods are complete on June 30, all non-winning entries will not be included in subsequent drawings. Need not be present to win.

Odds of winning a prize depend on the number of eligible entries received during the applicable Entry Periods. The winners of the Prizes will be drawn from the pool of eligible entries submitted. Limit: One (1) prize per person. Total value of all prizes: \$3,200

7. Prizes: Each academic year, there will be two separate prize drawings. Each February and July a drawing will be held for \$100 scholarship savings account for each school district area (AHSTW, Exira-EHK, Harlan Community, IKM-Manning, MVAOCOU, and OABCIG). Students in schools adjacent to these schools above are also eligible to enter. Those entries will be combined with entries in the closest, aforementioned schools. All entries obtained throughout the prior academic year from each school will be combined into the grand prize drawing in July for one of (2) \$1,000 scholarship saving accounts. Each winning entrant will be notified by an SCSB employee. The prizes must be deposited into an existing account of the winner at SCSB or a new account may be opened by the winner.

Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use.

- 8. **Release:** By entering, each entrant agrees to release and hold harmless SCSB and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize.
- 9. **Publicity:** Sponsor may issue press releases containing the winner's name and announcing the winner's Prize, with the consent of the winner and the winner's parents (if the winner is a minor). Sponsor will not otherwise release winner's names to the public.
- 10. **Taxes:** All applicable taxes, including any federal, state, or local tax liabilities, are the sole responsibility of the winner(s) and the winner(s) and the winners may receive an IRS form 1099 for the appropriate retail value of the prize. Prize winnings of \$600 or more subject to state and federal income tax requirements.
- 11. **General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures, human error, or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all the prizes offered herein. Sponsor reserves the right, in its

sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes, if it is possible. Disputes: Except where prohibited, entrant agrees that: (1) Any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action. (2) Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Iowa without giving effect to any choice of law or conflict of law rules which would cause the application of the laws of any jurisdiction other than the State of Iowa.
